Leaving a bequest to the University in my Will

Testamentary bequests
Bequests made by US taxpayers to the University of Sheffield in America are deductible for US estate tax purposes, and there is no limit on the amount of charitable estate tax deduction.

Suggested wording for a Will or Codicil, to be discussed with your lawyer:

'I leave, devise and bequeath the sum of \$ to 'University of Sheffield in America, Inc.', EIN 30-0207689, a 501(c)(3) organization established under the laws of Delaware, or, if such organization is not still in existence and a 501(c)(3) organization, then to the University of Sheffield in Sheffield, UK.'

Corporate matching gifts
The University of Sheffield in America can also accept tax deductible contributions from US corporate matching gifts programs. Please send the relevant documents with your donation.

Pledges
If you wish to make a substantial gift, it may be possible to pay the donation over a number of years. Recognition* for the donation, and the establishment of any associated scholarship or award, will begin on payment of the first phase of the gift, subject to a written agreement.
